- Each breeding animal may be shown in one classification only—The same animal cannot be shown in the youth class and shown again in Open Class.
- Enter grounds through the Exhibitors' gate—No animal will unload until vet checked. Have all papers ready.
- Arrival times for animals are **Saturday from 5pm-9pm** and Sunday from **7 am-12 noon**.
- All animals must be on the grounds by **Sunday July 18, 2021 at noon**.
- Non-market animals will be released on **Sunday, July 25, 2021 at 6 am**.
- Exhibitors are not permitted to sleep in barns—any one staying overnight must be registered in a camper.
- All open entries must show proof of ownership/lease upon request.
- Failure to show these open class entries (unless under extreme medical emergency) will result in forfeiture of present and future fair passes.
- Open class youth exhibitors will receive one free pass. Adult open class exhibitors will receive one free pass per address, not per exhibitor. Exhibitor passes are non-ride passes per new carnival policy. Exhibitor's immediate family must purchase passes for \$45 (ride passes).
- Late entries are not eligible for premiums.
- Exhibitor forfeits all premiums not cashed within sixty days of the close of the fair.
